87200 Filer	Form 87200 filers shall complete all schedules for Form 700 and disclose all reportable sources of income, interests in real property, investments and business positions in business entities, if applicable, pursuant to Government Code Section 87200 <i>et seq.</i>
OC-48	All interests in real property in Orange County, as well as all investments in, business positions with, and income (including gifts, loans and travel payments) from sources engaged in the direct or indirect provision of early development services to or for children. As used herein, "early development services" means the services which the Commission is authorized by statute to promote, support or improve.
OC-52	Investments in, business positions with, and income (including gifts, loans and travel payments) from sources engaged in the direct or indirect provision of early development services to or for children. As used herein, "early development services" means the services which the commission is authorized by statute to promote, support or improve.
