

**AMENDMENT NO. 2
TO
CONTRACT MA-080-26010368
FOR
JANITORIAL SERVICES**

This AMENDMENT is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California (“County”) and US Metro Group, Inc., with a place of business at 6803 International Ave., Suite 101, Cypress, CA 90630 (“Contractor”), with County and Contractor sometimes individually referred to as “Party” or collectively referred to as “Parties”.

RECITALS

WHEREAS, the County acting through the County Procurement Office (“CPO”), issued a Regional Cooperative Contract (“RCA”) number RCA-017-22010002 for Janitorial Services, effective September 1, 2021 through August 31, 2026; and,

WHEREAS, County and Contractor entered into Contract MA-080-26010368 for Janitorial Services, effective September 17, 2025 through June 17, 2026, in the Total Contract Not-to-Exceed, Amount of \$199,964.37 (“Contract”); and,

WHEREAS, the Parties amended the Contract to extend the term and increase Contract amount by \$52,036.66; and,

WHEREAS, CPO extended RCA for one year effective September 1, 2026 through August 31, 2027; and,

WHEREAS, the Parties now desire to extend the Contract for one year effective September 1, 2026 through August 31, 2027 with a Total Contract Amount of \$516,120.19; and,

NOW THEREFORE, the Parties agree as follows:

AMENDMENT TO CONTRACT ARTICLES

1. Article 2 of the Contract shall be amended to include the following:

Contract shall be extended for one year effective September 1, 2026, through August 31, 2027, unless otherwise terminated by County.

2. Article 4 of the Contract shall be amended in its entirety as follows:

4. Not to Exceed Limit: The total amount of this Contract shall not exceed **\$516,120.19**. The County shall have no obligation to pay any sum in excess of this amount unless authorized by written amendment signed by both Parties.

3. Attachment B – Payment/Compensation, Section 2, Item C shall be amended in its entirety as follows:

C. TOTAL CONTRACT AMOUNT NOT TO EXCEED: \$ **516,120.19**

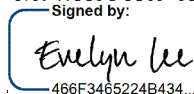
4. All other terms and conditions in this Contract shall remain unchanged and with full force and effect.

* If the contracting party is a corporation, (2) two signatures are required: one (1) signature by the Chairman of the Board, the President or any Vice President; and one (1) signature by the Secretary, any Assistant Secretary, the Chief Financial Officer or any Assistant Treasurer. The signature of one person alone is sufficient to bind a corporation, as long as he or she holds corporate offices in each of the two categories described above. For County purposes, proof of such dual office holding will be satisfied by having the individual sign the instrument twice, each time indicating his or her office that qualifies under the above described provision. In the alternative, a single corporate signature is acceptable when accompanied by a corporate resolution demonstrating the legal authority of the signator to bind the corporation.
