

**AMENDMENT NUMBER ONE
TO SUBORDINATE CONTRACT MA-026-25011305
FOR MICROSOFT UNIFIED SUPPORT SERVICES
BETWEEN
COUNTY OF ORANGE
FOR THE OFFICE OF THE DISTRICT ATTORNEY - PUBLIC ADMINISTRATOR
AND INSIGHT PUBLIC SECTOR, INC.**

This Amendment Number One (“Amendment”) to Subordinate Contract MA-026-25011305 (“Contract”) is made and entered into as of the date fully executed by and between Insight Public Sector, Inc., an Illinois Corporation (“Contractor”), and the County of Orange, a political subdivision of the State of California, acting through the Office of the District Attorney–Public Administrator (“County”), which are sometimes referred to as a “Party” or collectively as the “Parties”.

RECITALS

WHEREAS, the County Procurement Office issued Regional Cooperative Agreement RCA-017-25010022 (“County RCA”) for Microsoft Enterprise Products and Services, effective November 1, 2024, and expiring on October 31, 2027; and

WHEREAS, the Parties entered into the Contract for Microsoft Unified Support Services commencing on June 28, 2025, and expiring on June 27, 2028, for the not-to-exceed amount of \$2,424,178; and

WHEREAS, the Parties desire to amend the Contract to increase the contract amount by \$45,552.40 for the term of June 28, 2025, through and including June 27, 2028, for a new cumulative amount of \$2,469,730.13;

NOW THEREFORE, in consideration of the mutual obligation set forth herein, the Parties agree as follows:

1. Section IV of the Scope of Work, Pricing and Payment Information shall be deleted and replaced in its entirety with the following:

IV. FEES AND CHARGES: County will pay the following fees in accordance with the provisions of this Contract and RCA-017-25010022. Payment shall be as follows:

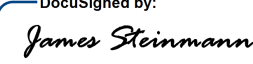
