

AMENDMENT NO. 3
TO CONTRACT MA-080-22010258
FOR
SANTA ANA-DELHI CHANNEL IMPROVEMENT PROJECT

This Amendment is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California, Orange County Flood Control District, a body corporate and politic, hereinafter collectively referred to as ("County"), and Geosyntec Consultants, Inc., a Florida Corporation ("A-E"), with County and A-E sometimes individually referred to as "Party" or collectively referred to as "Parties."

RECITALS

WHEREAS, the County and A-E entered into Contract MA-080-22010258 for Owner's Representative Services for the Santa Ana-Delhi Channel Improvement Project, effective October 19, 2021, through October 18, 2028, in an amount not-to-exceed \$4,700,000; and

WHEREAS, pursuant to Amendment No.1, the Parties amended the Contract to add the minimum limits and coverage of insurance to be maintained by Subcontractors; and

WHEREAS, pursuant to Amendment No.2, the Parties amended the Contract to increase the Total Contract Amount by \$200,000 for a new Total Contract Amount not to exceed \$4,900,000; and

WHEREAS, the Parties now desire to amend the Contract to increase the maximum allowable compensation by One Million, Five Hundred Fourteen Thousand, Five Hundred and Four Dollars (\$1,514,504) for a new Total Contract Amount not to exceed \$6,414,504; and

WHEREAS, the Parties now desire to extend the Contract for three years, effective through October 18, 2031 ; and

NOW, THEREFORE, the Parties agree as follows:

ARTICLES

1. Section 1.4.1 shall be amended to read in its entirety as follows:

1.4. Term and Maximum Compensation

The term of this Contract is for ten (10) years, commencing upon Board of Supervisor approval, with a maximum allowable compensation of Six Million, Four Hundred Fourteen Thousand, Five Hundred and Four Dollars (\$6,414,504), except as permitted in Paragraph 1.5 below.

2. Attachment B, Section II, Paragraph B shall be amended to read in its entirety as follows:

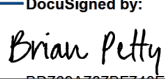
Total CONTRACT Amount Shall Not Exceed: \$6,414,504

3. All other terms and conditions of the Contract shall remain unchanged and with full force and effect.

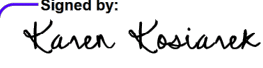

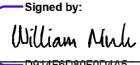
