WHEREAS, the Parties desire to amend the ORIGINAL CONTRACT to address changes mandated by the California Public Utilities Commission (“CPUC”) Adopting Permanent Rate Relief for Incarcerated Persons Calling Services, Rulemaking 20-10-002 released on issued on April 13, 2026, (the “2026 CPUC Order”) to implement a permanent intrastate voice communication rate cap of \$0.045 per minute, and

WHEREAS, the Parties desire to amend the ORIGINAL CONTRACT to amend Attachment A - Scope of Work, Attachment B - Rates and Fees, and Attachment C - Revenue Sharing and

Cost Recoupment; and the CONTRACTOR has agreed to continue to provide the Inmate Communication Services at the rates set forth in this AMENDMENT NUMBER THREE;

NOW, THEREFORE, the Parties mutually agree as follows:

1. ATTACHMENTS

- a. Attachment A – Scope of Work to the ORIGINAL CONTRACT is hereby amended and replaced in its entirety with the Attachment A – Scope of Work attached to this AMENDMENT NUMBER THREE.
- b. Attachment B – Rates and Fees to the ORIGINAL CONTRACT is hereby amended and replaced in its entirety with the Attachment B – Rates and Fees attached to this AMENDMENT NUMBER THREE.
- c. Attachment C – Revenue Sharing and Cost Recoupment to the ORIGINAL CONTRACT is hereby amended and replaced in its entirety with the Attachment C – IPCS Facility Cost Rate Additive and Tablet Commission attached to this AMENDMENT NUMBER THREE.

2. ARTICLES

- a. Additional Terms and Conditions, Section 2, Term of Contract, of the ORIGINAL CONTRACT is amended in its entirety as follows:
 2. Term of Contract: This Contract shall commence upon execution of all necessary signatures and continue in effect from 5/24/2022 through and including 5/23/2030, unless otherwise terminated by COUNTY.
- b. Additional Terms and Conditions, Section 3, Renewal, of the ORIGINAL CONTRACT is amended in its entirety as follows:
 3. Renewal: This Contract may be renewed by mutual written agreement of both Parties for two (2) additional, one (1) year terms. The County does not have to give reason if it elects not to renew. Renewal periods may be subject to approval by the County of Orange Board of Supervisors.

3. EFFECTIVE DATES

- a. CPUC-Mandated Change. The intrastate voice communication rate cap required under the 2026 CPUC Order shall become effective June 29, 2026, regardless of the date this AMENDMENT NUMBER THREE is executed.
- b. All Other Changes. All other modifications set forth in this AMENDMENT NUMBER THREE shall become effective as of the AMENDMENT EFFECTIVE DATE, unless otherwise expressly stated herein.
