

**AMENDMENT NO. 1
TO AGGREGATE CONTRACT MA-080-23011241
BETWEEN
COUNTY OF ORANGE
AND
HABITAT WEST, INC.
FOR
MITIGATION MAINTENANCE SERVICES**

This Amendment (“Amendment”) to Aggregate Contract MA-080-23011241 for Mitigation Maintenance Services (“Contract”) is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California (“County”), Orange County Flood Control District, a body corporate and politic (“District”) and Habitat West, Inc., (“Contractor”), with County, District and Contractor sometimes referred to as “Party” or collectively as “Parties.”

RECITALS

WHEREAS, County, District, and Contractor entered into Aggregate Contract MA-080-23011241 for Mitigation Maintenance Services, effective October 12, 2023, through October 11, 2026, in the Total Contract Not-to-Exceed Amount of \$2,250,000.00; and,

WHEREAS, the Parties now desire to amend Attachment B, Payment/Compensation; and

WHEREAS, the County now desires to renew the Aggregate Contract effective October 12, 2026, through October 11, 2028, in an amount not to exceed \$1,500,000, for a new Total Contract Not-to-Exceed Amount of \$3,750,000; and,

NOW, THEREFORE, the Parties mutually agree as follows:

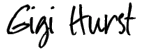
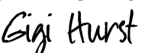

* If the contracting party is a corporation, (2) two signatures are required: one (1) signature by the Chairman of the Board, the President or any Vice President; and one (1) signature by the Secretary, any Assistant Secretary, the Chief Financial Officer or any Assistant Treasurer. The signature of one person alone is sufficient to bind a corporation, as long as he or she holds corporate offices in each of the two categories described above. For County purposes, proof of such dual office holding will be satisfied by having the individual sign the instrument twice, each time indicating his or her office that qualifies under the provision. In the alternative, a single corporate signature is acceptable when accompanied by a corporate resolution demonstrating the legal authority of the signee to bind the corporation.
