

**AMENDMENT NO. 1
TO AGGREGATE CONTRACT MA-080-23011241
BETWEEN
COUNTY OF ORANGE
AND
NATURES IMAGE, INC.
FOR
MITIGATION MAINTENANCE SERVICES**

This Amendment (“Amendment”) to Aggregate Contract MA-080-23011241 for Mitigation Maintenance Services (“Contract”) is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California (“County”), Orange County Flood Control District, a body corporate and politic (“District”), and Natures Image, Inc. (“Contractor”), with County, District and Contractor sometimes referred to as “Party” or collectively as “Parties.”

RECITALS

WHEREAS, County, District, and Contractor entered into Aggregate Contract MA-080-23011241 for Mitigation Maintenance Services, effective October 12, 2023, through October 11, 2026, in the Total Contract Not-to-Exceed Amount of \$2,250,000.00; and

WHEREAS, the County now desires to renew the Aggregate Contract effective October 12, 2026, through October 11, 2028, in an amount not to exceed \$1,500,000, for a new Total Contract Not-to-Exceed Amount of \$3,750,000;

NOW, THEREFORE, the Parties mutually agree as follows:

AMENDMENT TO CONTRACT ARTICLES

1. Aggregate Contract MA-080-23011241 shall be renewed effective October 12, 2026, through October 11, 2028, in an amount not to exceed \$1,500,000, for a new Total Contract Not-to-Exceed Amount of \$3,750,000.
2. All other terms and conditions in this Contract shall remain unchanged and with full force and effect.
