This Amendment Number One to Contract MA-017-23011290 (hereinafter referred to as "Amendment Number One") is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California ("County") and SCAN Health Plan, ("Contractor"), with County and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties".

Recitals

WHEREAS, County and Contractor entered into Contract MA-017-23011290 for Medicare Retiree Health Plans, effective January 1, 2024, through December 31, 2026; and,

WHEREAS, Parties now desire to renew Contract for an additional one (1) year term, effective January 1, 2027, through December 31, 2027; and

NOW THEREFORE, in consideration of the mutual obligations set forth herein, Parties agree as follows:

1. The Contract is hereby renewed for one (1) additional year, effective January 1, 2027, and expiring on December 31, 2027.
2. Paragraph 4 of the Contract is hereby amended to read in its entirety as follows:

"4. Term of Contract: The term of this Contract is for four (4) years effective January 1, 2024, continuing for four (4) years from that date, unless terminated by County. The Contract Term may be renewed for one (1) additional consecutive one (1) year term, upon the mutual written agreement of the Parties. Renewal of the Contract may require approval by the County Board of Supervisors. Permitted renewals of the Contract provided in this paragraph 4 shall not result in any change in any other term, condition or provision of this Contract."

3. All other terms and conditions in this Contract shall remain unchanged and with full force and effect.

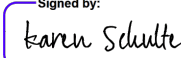
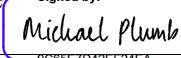
IN WITNESS WHEREOF, the Parties hereto have executed this Amendment on the date first above written.

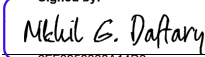
