**NOTICE OF INTENTION OF THE BOARD OF SUPERVISORS
OF THE COUNTY OF ORANGE, CALIFORNIA, ACTING AS THE
GOVERNING BOARD OF THE ORANGE COUNTY FLOOD CONTROL
DISTRICT, TO CONSIDER FOR ADOPTION A RESOLUTION PARTIALLY
RESCINDING RESOLUTION OF NECESSITY 25-007 TO REVISE DURATION
OF SUBJECT PROPERTY INTERESTS BEING ACQUIRED**

WHEREAS, on January 14, 2025, the Board of Supervisors (“Board”) adopted Resolution of Necessity 25-007 related to certain real property interests consisting of a 60-month temporary construction easement described and depicted therein (“Subject Property Interests”), which allowed for the acquisition of the Subject Property Interests through eminent domain for the OC Loop Segments O, P, Q Coyote Creek Bikeway (“Project”);

YOU ARE HEREBY NOTIFIED, pursuant to Code of Civil Procedure section 1245.235, that the Board intends to consider for adoption a resolution (the “Resolution”), a copy of which as proposed is attached to this Notice, partially rescinding Resolution of Necessity 25-007 and to clarify the duration for the use of the temporary construction easement being acquired by the County. The temporary construction easement will not be used for staging for the full 60-month period and instead will be used for only a portion of that time, not to exceed a period of twelve (12) consecutive months. The County shall mitigate any parking lost by the Owner during the use of the Temporary Easement by obtaining City approval to provide alternative replacement parking such that up to 32 parking spaces may be available. Additionally, the construction activities within the temporary easement may be completed in stages such that at most only 15 parking spaces are made unavailable for a maximum period of 6 consecutive months.

YOU ARE HEREBY NOTIFIED that the public hearing by the Board to consider adoption of the Resolution is set for 9:30 a.m. (or as soon thereafter as the Board meeting reaches the agenda item relating to this public hearing) on August 11, 2026, at the Board of Supervisors’ Hearing Room, Ground Floor, County Administration North Building, 400 W. Civic Center Drive, Santa Ana, California.
