



**AMENDMENT NO. 3
TO
CONTRACT NO. MA-042-22010732
FOR
INPATIENT BEHAVIORAL HEALTH SERVICES**

This Amendment (“Amendment No. 3”) to Contract No. MA-042-22010732 for Inpatient Behavioral Health Services is made and entered into on May 19, 2026 (“Effective Date”) between Aliso Ridge Behavioral Health, LLC (“Contractor”), with a place of business at 200 Freedom Lane, Aliso Viejo, CA 92656, and the County of Orange, a political subdivision of the State of California (“County”), through its Health Care Agency, with a place of business at 405 W. 5th St., Ste. 600, Santa Ana, CA 92701. Contractor and County may sometimes be referred to individually as “Party” or collectively as “Parties”.

RECITALS

WHEREAS, the Parties executed Contract No. MA-042-22010732 for Inpatient Behavioral Health Services, effective February 12, 2022 through June 30, 2024, in an amount not to exceed \$2,422,500, renewable for two additional one-year periods (“Contract”); and

WHEREAS, the Parties executed Amendment No. 1 to increase the Contract’s Period Two Amount Not To Exceed by \$10,305,000 and Period Three Amount Not To Exceed by \$15,887,305, for a new revised cumulative amount not to exceed \$28,615,000, and to add Paragraph XXX. and to amend Exhibit A of the Contract, effective December 20, 2022; and

WHEREAS, the Parties executed Amendment No. 2 to add Paragraph XXXI. to the Contract, to amend Exhibit A of the Contract, and to renew the Contract for two years, effective July 1, 2024 through June 30, 2026, in an amount not to exceed \$33,390,000, for a new revised cumulative amount not to exceed \$62,005,000; and

WHEREAS, the Parties now desire to enter into this Amendment No. 3 to increase the Contract’s Period Five Amount Not To Exceed by \$2,405,533; to amend Exhibit A of the Contract; and to extend the Contract for six (6) months for County to continue receiving and Contractor to continue providing the services set forth in the Contract.

NOW THEREFORE, Contractor and County agree to amend the Contract as follows:

1. The Contract’s Period Five Amount Not To Exceed is increased by \$2,405,533, from \$16,695,000 to \$19,100,533.
2. The Contract is extended for a period of six (6) months, effective July 1, 2026, through December 31, 2026, in an amount not to exceed \$9,363,150 for this renewal period, for a revised cumulative amount not to exceed \$73,773,683.
3. Referenced Contract Provisions, Term provision and Amount Not To Exceed provision, of the Contract are deleted in their entirety and replaced with the following:

“**Term**: February 12, 2022 through December 31, 2026
 Period One means the period from February 12, 2022 through June 30, 2022
 Period Two means the period from July 1, 2022 through June 30, 2023

Period Three means the period from July 1, 2023 through June 30, 2024
 Period Four means the period from July 1, 2024 through June 30, 2025
 Period Five means the period from July 1, 2025 through June 30, 2026
 Period Six means the period from July 1, 2026 through December 31, 2026

4. Exhibit A, Paragraph IV. Payments, subparagraph A (not including A.1 through A.5), of the Contract is deleted in its entirety and replaced with the following:

“A. CONTRACTOR shall be reimbursed for services provided at the following Bed Day Rates per client day for acute Psychiatric Inpatient Hospital Services, based on the following accommodation codes and age groups:


