

RESOLUTION OF THE BOARD OF SUPERVISORS OF  
ORANGE COUNTY, CALIFORNIA

December 7, 2010

WHEREAS, California Vehicle Code Section 40200, *et seq.* authorizes the Board of Supervisors to apply civil fines and penalties for violations of any regulation pertaining to the standing or parking of a vehicle, as specified in the California Vehicle Code, any federal statute or regulation, or any local ordinance; and

WHEREAS, such civil penalties ensure public safety by moderating traffic flow and ensuring safe access to the roads and highways; and

WHEREAS, collecting such civil penalties ensure public safety by funding public works projects directly related to the construction and maintenance of state courthouses; and

WHEREAS, the State of California, pursuant to California Government Code Section 70372, has increased the "state court construction penalty" to \$4.50 for every parking citation issued within the state to fund the "State Court Facilities Construction Fund"; and

WHEREAS, the County of Orange has previously adopted two (2) \$2.50 penalties for every parking citation as authorized under Government Code Section 76000(b) and adopted by Resolution 1991-1336 to fund the Criminal Justice Facilities Planning Fund and the Courthouse Construction Fund, respectively; and

WHEREAS, California Vehicle Code Section 40203.5(a) provides that, to the extent possible, agencies issuing parking citations within the same county shall standardize their parking penalties; and

WHEREAS, the California state legislature has enacted a \$3.00 penalty for every parking citation as authorized pursuant to Government Code Section 76000.3 to benefit the Trial Court Trust Fund;

WHEREAS, the Orange County Sheriff's Department now proposes the adoption of the Uniform Traffic Bail Schedule of 2010-A (attached hereto and incorporated herein by reference).

**NOW, THEREFORE, BE IT RESOLVED** that this Board does hereby:


