**AMENDMENT NO. 3
TO CONTRACT MA-299-23010511
FOR
A-E TASK ORDER CONTRACT FOR LANDFILL SERVICES**

This AMENDMENT is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California ("County") and SWT Engineering, Inc., a California Corporation ("A-E"), with County and A-E sometimes individually referred to as "Party" or collectively referred to as "Parties."

RECITALS

WHEREAS, the County and A-E entered into Contract MA-299-23010511 (the "Contract") for A-E Task Order Contract for Landfill Services, effective January 10, 2023, through January 09, 2026, with a maximum allowable compensation of \$3,000,000; and

WHEREAS, on December 2, 2025, the Orange County Board of Supervisors approved Amendment One to extend the Contract for six months, effective January 10, 2026 through July 09, 2026, with no change to the maximum allowable compensation, for a cumulative Contract amount not to exceed \$3,000,000; and

WHEREAS, on January 13, 2026, the Orange County Board of Supervisors approved Amendment Two to increase the Contract in the amount of \$500,000, for a cumulative Contract amount not to exceed \$3,500,000; and

WHEREAS, The Orange County Board of Supervisors approved the On-Call contract name change language on February 24, 2026; and

WHEREAS, County is now replacing the Contract title, and all references originally titled, *On-Call Landfill Services, for A-E Task Order Contract for Landfill Services*; and

WHEREAS, County now desires to extend the current Contract through January 31, 2027, and increase the current Contract in the amount of \$850,000, for a cumulative Contract amount not to exceed \$4,350,000;

NOW THEREFORE, the Parties agree as follows:

ARTICLES

1. Contract MA-299-23010511 shall now be titled A-E Task Order Contract for Landfill Services.
2. Contract MA-299-23010511 shall be extended through January 31, 2027, and increased in the amount of \$850,000, for a cumulative Contract amount not to exceed \$4,350,000.
3. All other terms and conditions of the Contract shall remain unchanged and with full force and effect.


