



## SUBORDINATE CONTRACT

SUBORDINATE CONTRACT NO. PO-060-26010640 with Insight Public Sector, Inc. is hereby issued per the terms and conditions of Regional Cooperative Agreement RCA-017-24010043 for Technology Product Solutions and Services.

This Contract PO-060-26010640 is made and entered into upon execution of all necessary signatures between Insight Public Sector, Inc., having its principal place of business at 2701 E. Insight Way, Chandler, AZ 85286 (hereinafter referred to as "Contractor"), and the County of Orange, a political subdivision of the State of California (hereinafter referred to as "County"), acting through the Orange County Sheriff-Coroner Department, with a place of business at 320 N. Flower Street, 2<sup>nd</sup> Floor, Santa Ana, CA 92703 (hereinafter referred to as "Sheriff-Coroner"), which are sometimes individually referred to as "Party" or collectively referred to as "Parties".

### RECITALS

WHEREAS, the County of Orange, acting through the County Executive Office, and Contractor executed a Regional Cooperative Agreement RCA-017-24010043 on October 1, 2024 for Technology Product Solutions and Services (hereinafter referred to as "RCA"), now in effect from October 1, 2024 through and including April 30, 2026; and

WHEREAS, Term 10 of the RCA, entitled "Cooperative Agreement", allows other California local or state governmental entities to utilize the RCA with the same provision and pricing; and

WHEREAS, County, acting through the Sheriff-Coroner, and Contractor desire to enter into a Subordinate Contract for Technology Product Solutions and Services pursuant to the terms, conditions and pricing of the RCA, which is attached hereto and incorporated herein by reference as Attachment A;

NOW, THEREFORE, the parties mutually agree:

1. **Scope of Contract:** This Subordinate Contract specifies the terms and conditions by which the County, acting through the Sheriff-Coroner, will procure Technology Product Solutions and Services from the Contractor (hereinafter referred to as "Services") as more fully detailed in Attachment A, Regional Cooperative Agreement RCA-017-24010043.
2. **Term of Subordinate Contract:** This Subordinate Contract shall commence upon execution of all necessary signatures through December 7, 2026 and shall continue to be in effect and continue to incorporate the terms and conditions of RCA-017-24010043 regardless of whether RCA-017-

24010043 terminates or expires prior to the expiration or termination of this Subordinate Contract.

3. Renewal: This Contract may not be renewed.
4. Compensation & Payment: Contractor agrees to provide the Services in accordance with the terms and condition of the RCA, including its attachments, and at the fixed rates as set forth in Attachment B – Compensation, Pricing and Payment of the RCA. The total cost of this Subordinate Agreement shall not exceed \$206,986.94. The County shall have no obligation to pay any sum in excess of this amount unless authorized by written amendment signed by both Parties.
5. Invoicing: Invoicing shall be done in accordance with the terms and conditions of Attachment B – Compensation, Pricing and Payment of the RCA. Vendor shall reference Subordinate Contract PO-060-26010640 on invoices. Invoices are to be submitted to the Sheriff-Coroner Division requesting the Services:

Any written communications shall be deemed to have been duly given upon actual in-person delivery, if delivery is by direct hand, or upon delivery on the actual day of receipt or no greater than four (4) calendar days after being mailed by US certified or registered mail, return receipt requested, postage prepaid, whichever occurs first. The date of mailing shall count as the first day. All communications shall be addressed to the appropriate party at the address stated herein or such other address as the parties hereto may designate by written notice from time to time in the manner aforesaid.
