Pesticide Use Enforcement

Pesticides are an important tool to help manage pests that negatively impact our food supply, cause damage to structures, degrade our native ecosystems, and spread harmful diseases, however they may pose risks if used inappropriately. To mitigate these risks, California maintains one of the nation’s strictest pesticide regulatory programs to ensure that pesticides are utilized safely and effectively.

This year’s report shines a spotlight on the important programs in our office that ensure that Orange County residents, workers, and the environment are safeguarded from pesticide misuse. These programs represent the wide range of responsibilities managed by the Orange County Pesticide Use Enforcement division, highlighting our vital role in protecting human health and the natural environment while supporting safe and effective pest management.

It is my pleasure to present the 2025 Orange County Crop Report as prepared pursuant to Sections 2272 and 2279 of the California Food and Agricultural Code. The values represented in this report reflect the gross value of agricultural commodities grown in Orange County, and not the costs associated with production, labor, harvesting, preparation for market, and added value activities.

This report reflects a total agricultural production value of \$81,508,000 for 2025, representing a 10% increase from 2024. Nursery products remain the county's leading agricultural commodity, accounting for more than 48% of total production value, with a modest 5% increase over the previous year.

Despite ongoing challenges common to a highly urban county, including rising labor costs and a continued reduction in available agricultural land, the non-nursery crop commodities collectively grew by 16%. This growth was driven primarily by higher commodity prices and improved yields, demonstrating the industry's ability to adapt and remain productive under constrained conditions.

High-value crops adapted to smaller, intensively managed production areas continued to perform well, with strawberries and avocados showing notable gains as a result of improved production efficiency and sustained market demand.

This report is produced each year with the outstanding partnership and cooperation of the nursery industry, ranchers, farmers, and educational programs that represent the agricultural industry in Orange County. My appreciation goes to all producers, growers, and individuals in the agribusiness sector for their assistance in providing the data to make this report possible. I also extend my sincere thanks to the exceptional staff here at Orange County Agriculture, Weights & Measures Office who help in the compilation and preparation of this report.

History of Pesticide Regulation

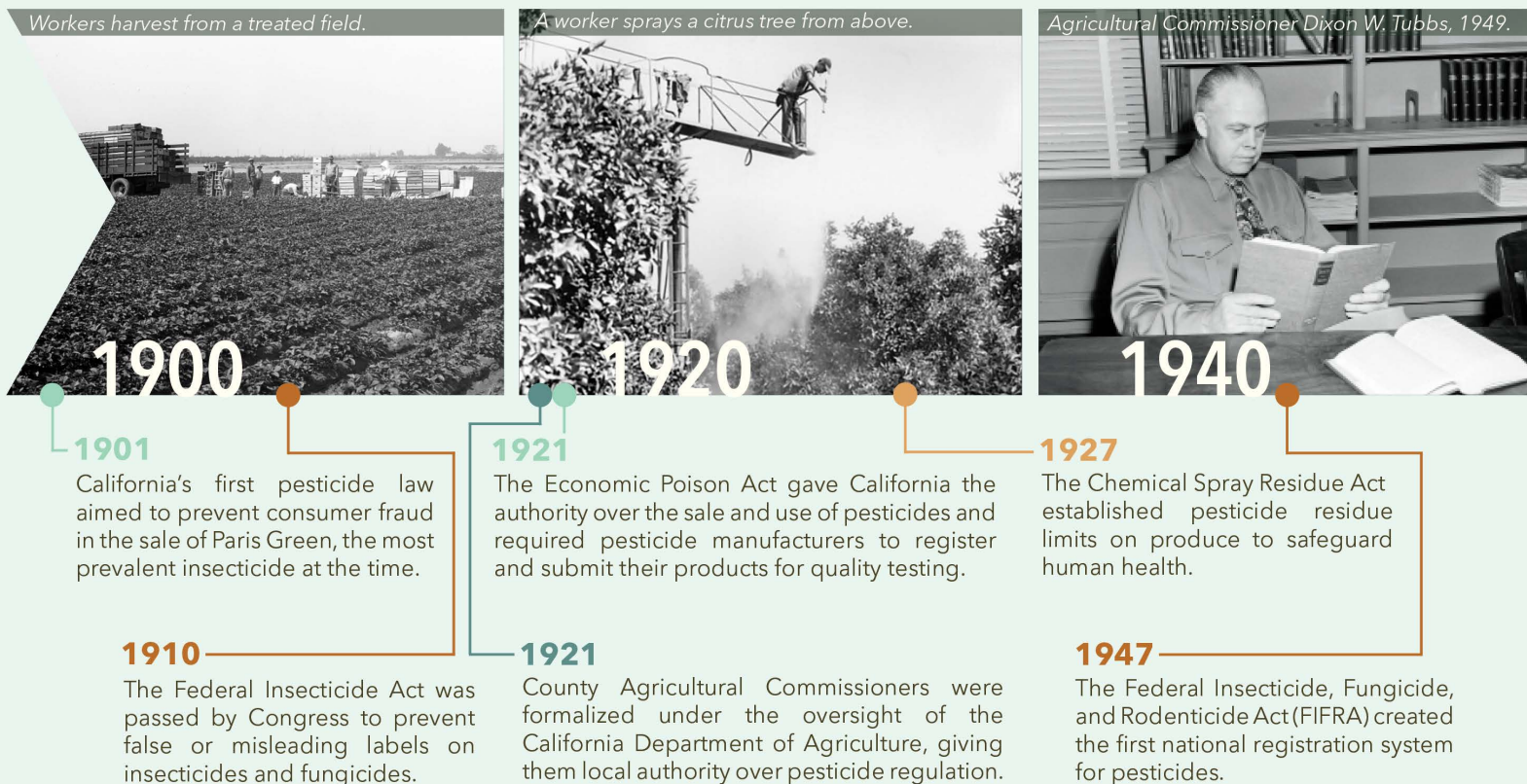
California began regulating pesticides in 1901 with its first pesticide law, which focused on preventing fraud by requiring accurate labeling and product verification to ensure growers were not sold ineffective or misbranded products. As agriculture expanded and the risks of pesticide use became better understood, the state adopted stronger requirements for product registration, labeling, and enforcement.

Today, California has one of the most comprehensive pesticide regulatory programs in the nation. Before a pesticide can be sold or used, it must undergo extensive scientific review to evaluate potential risks to people, wildlife, water, and air quality. State and county agencies regulate pesticide use and enforce stringent laws and regulations, helping ensure pesticides are used responsibly while supporting agriculture and protecting public health.

The Impact in Orange County

Orange County Agriculture, Weights & Measures is committed to the oversight of safe and lawful pesticide use to ensure the protection of the health and safety of our nearly 3.2 million residents and to safeguard our environment. The California law delegates local enforcement of pesticide laws and regulations to each County Agricultural Commissioner. Orange County ranks among the top pesticide enforcement programs in California at 4th in inspections, 4th in number of investigations, and 6th in enforcement responses.

From 2020 through 2025, Orange County's Pesticide Use Enforcement program conducted more than 15,000 compliance inspections, completed over 400 injury and illness investigations, reviewed and issued more than 1,100 restricted material permits, provided 98 pesticide safety outreach events, and identified more than 1,200 violations.

Pesticide Regulation Programs

COMPLIANCE MONITORING

Our licensed inspectors conduct 24 distinct types of regulatory compliance inspections including agricultural and structural pesticide use monitoring, worker safety training records audits, personal protective equipment and pesticide storage assessments, pre-application site evaluations, fumigation monitoring, and pesticide dealer sales records audits. These inspections ensure that pesticides are being applied appropriately by licensed professionals using safe and effective equipment and methods.

INJURY, ILLNESS, & COMPLAINT INVESTIGATIONS

Our staff investigate all complaints of injuries, illnesses, or property loss caused by or suspected to be caused by the use of a pesticide.

RESTRICTED MATERIAL PERMITTING

Our office administers a rigorous permitting system for any operators to purchase, store, or apply any products designated as a California restricted material. These permits are evaluated on an annual basis to ensure that only properly licensed professionals apply these products in a tightly-regulated, site-specific manner.

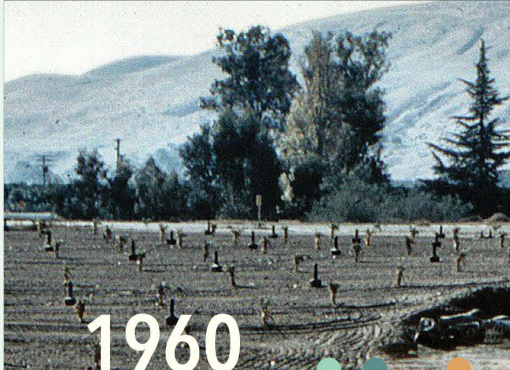
ENFORCEMENT RESPONSE

California law provides the authority to levy administrative civil penalties when an inspection or investigation finds a violation. These enforcement actions follow due process and are intended to promote and support future compliance.

OUTREACH & EDUCATION

We provide proactive regulatory trainings, tools, and updates to assist with industry compliance and public education and awareness.

The Healthy Schools Act directed the Department of Pesticide Regulation to implement low-risk Integrated Pest Management practices at public schoolsites.

Compliance Monitoring

Pesticide use compliance monitoring is our largest pesticide safety program. Licensed inspectors conduct countywide surveillance and inspect pesticide applications to ensure applicators are properly trained and licensed, pesticides are used according to label requirements, equipment and personal protective equipment (PPE) are in good condition, required notifications are provided, and emergency medical information is available on site.

In 2025 we completed 897 pesticide safety inspections across agricultural, residential, commercial, industrial settings. These inspections identified 129 violations, with over a third of these violations involving employers failing to provide their employees with required PPE or failing to maintain required safety trainings.

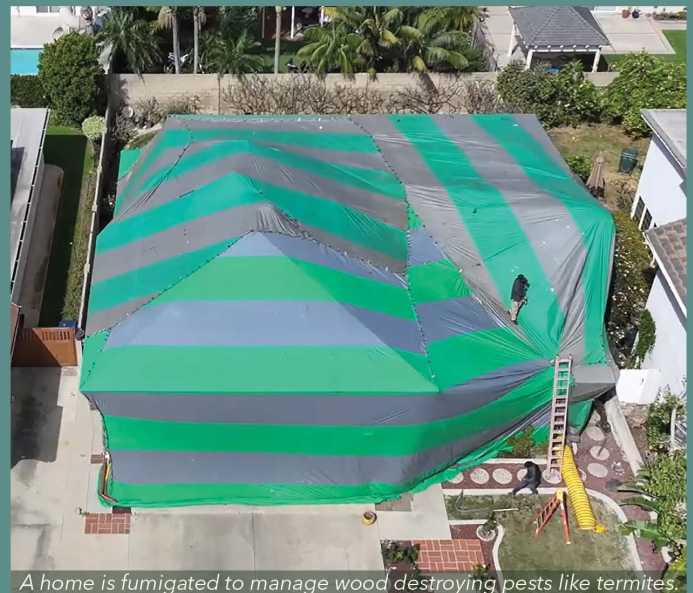
- ▶ **102 PRE-APPLICATION SITE EVALUATIONS** are performed before proposed applications of restricted materials.
- ▶ **103 FIELD WORKER SAFETY** interviews with agricultural field workers to ensure they have received pesticide safety training.
- ▶ **104 PESTICIDE USE MONITORING** at agricultural sites including right of ways, golf courses, cemeteries, parks, and more.
- ▶ **105 COMMODITY FUMIGATION** inspections are performed on food, feed, and grain pest fumigation treatments.
- ▶ **106 FIELD FUMIGATION USE MONITORING** ensures that soil fumigation injections in agricultural fields are performed safely.

STRUCTURAL FUMIGATION ENFORCEMENT PROGRAM

Fumigation Monitoring

Orange County's Pesticide Use Enforcement division participates in the Structural Fumigation Enforcement Program, an industry-funded compliance initiative that supports increased oversight over building fumigations used to control structural pests such as termites, wood-boring beetles, bed bugs, and rats. Orange County has the third highest number of fumigations in California.

Our inspectors conduct inspections during each stage of a fumigation, from initial tarping and fumigant injection to interim tarp integrity checks to final teardown and clearance testing to ensure the building is safe for re-entry. In 2025, our inspectors performed 533 fumigation compliance inspections.

Pesticide Investigations

Our agency investigates all pesticide-related complaints, reports of injuries or illnesses, and pesticide emergencies to determine whether pesticides were misused and works with responsible parties to achieve compliance and prevent future incidents. Reports are forwarded from statewide reporting portals such as the California Governor's Office of Emergency Services (Cal OES) and the California Poison Control System, Workers Health and Safety (WHS) reports, Doctor's First Reports of Occupational Illness and Injury, and direct complaints from concerned members of the public.

Every incident is responded to with a full investigatory report, and priority incidents involving serious health effect, large-scale wildlife and livestock losses, or major environmental contamination are formally documented and reported to the U.S. Environmental Protection Agency. In 2025, the program completed 124 investigations involving potential human exposure, environmental impacts, pesticide drift, property damage, wildlife incidents, and other community concerns.

SAFETY TIPS FOR USING PESTICIDES AT HOME

FOLLOW THE LABEL, IT'S THE LAW!

Follow all instructions on the pesticide label on how, where, and how much to apply.



NEVER STORE PESTICIDES IN FOOD CONTAINERS

Store pesticides in original or labeled containers. Never use food containers or drink bottles.



USE PERSONAL PROTECTIVE EQUIPMENT

Wear all personal protective equipment (PPE) required by the pesticide label.



Restricted Material Permits

Orange County's Pesticide Use Enforcement program administers California's Restricted Materials Permit Program, one of the nation's most rigorous pesticide control systems. Certain pesticides are classified as "restricted materials" because of their potential risks to human health and the environment. Before these products may be purchased or used, licensed pest control businesses and property operators must apply for a restricted materials permit.

In 2025, we issued 169 restricted material permits to entities, including municipalities and pest control businesses. Each permit undergoes rigorous evaluation to determine that proposed applications are conducted in a manner that protects people and the environment. We approve site- and time-specific permits only after evaluating environmental impacts and required safeguards, a process that serves as the functional equivalent of a CEQA Environmental Impact Report. After permit issuance, each proposed application must be reported to our office in advance so we may evaluate local conditions such as target pests, proximity to homes, schools, and sensitive sites before approving any applications.

Enforcement Responses

When violations are identified in the field, the County Agricultural Commissioner has the responsibility to document our findings and take appropriate enforcement actions. Enforcement actions include compliance notices and warning letters and administrative civil penalties, all applied under statewide standards established by California laws and regulations. This approach promotes compliance, protects public health and worker safety, and ensures pesticide laws are enforced consistently.

In 2025, we processed 104 enforcement actions and 65 compliance actions in response to violations documented during compliance inspections, records audits, and investigations. Forty percent of violations involved worker safety, including inadequate or damaged PPE and insufficient safety training.



Outreach & Education

Our Pesticide Use Enforcement program is committed to supporting our communities and regulated industries by providing important information regarding regulatory updates, industry best practices, and compliance support. In 2025, we held 33 outreach events, providing meaningful engagement with 1,448 licensees and members of the public and strengthening public safety, environmental stewardship, and regulatory compliance.



Total Production Value

In 2025, Orange County remained California’s third-most populous county, accounting for just over 8% of the state’s residents. Although ongoing urban development continues to reduce the amount of land available for farming, and rising costs and retirements have led some growers to scale back or cease operations, the overall value of agricultural production saw a notable rebound.. In 2025, the county’s agricultural output reached \$81,500,000, representing an increase of approximately 10% compared with the previous year. This increase is encouraging despite the long-term challenges facing local producers.

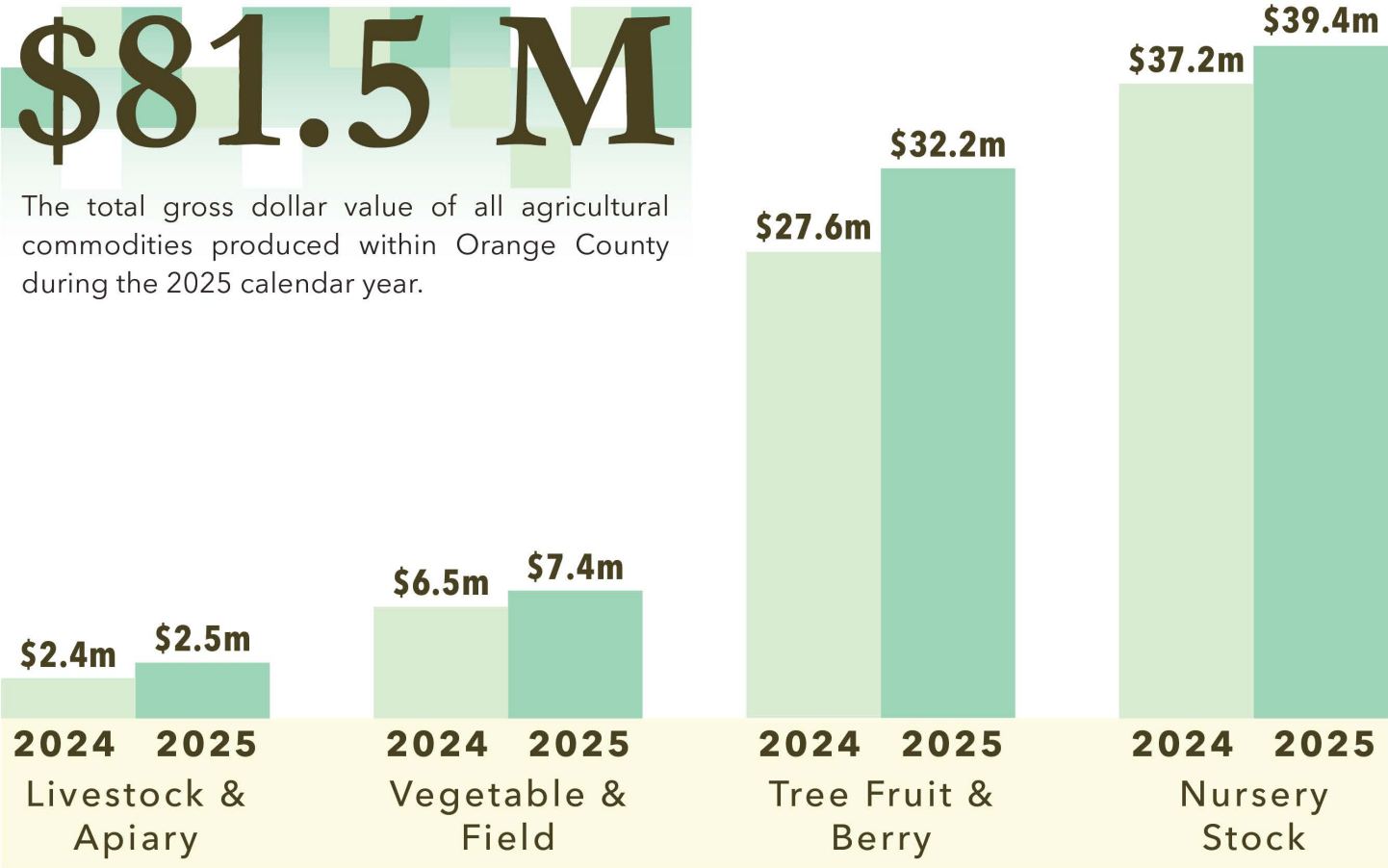

Export Certification

Foreign and domestic markets remain important destinations for Orange County’s agricultural products, and strict import requirements need to be met to prevent the spread of harmful pests and plant diseases. Regulated commodities such as plants, seeds, fruits, vegetables, lumber, and grain must be accompanied by a Phytosanitary Certificate to meet destination requirements. Our USDA-accredited inspectors review import requirements, verify documentation, and conduct detailed inspections to ensure our exports are pest-free, protecting California’s agricultural markets and our local economy.

In 2025, we issued 320 federal and 137 state phytosanitary certificates for shipments to international and domestic markets. Notably, 34 percent of international exports were destined for Mexico, highlighting its importance as a key trading partner for Orange County businesses.

Direct Marketing



Orange County inspectors certify a diverse range of producers, from backyard growers to large scale farms, through annual production site inspections, where they document crop varieties, production volumes, anticipated yields, and projected harvest timelines. In 2025, the program included 32 certified producers in Orange County, consisting of a variety of fruit and vegetable growers, honey producers, nursery cut flower producers, mushroom producers, and microgreen producers.

To maintain marketplace integrity, inspectors conduct unannounced regulatory inspections at Certified Farmers' Markets (CFMs) to verify that products offered for sale align with each grower's certified production. In 2025, 44 CFMs were registered, with each market inspected four times per year. Inspectors issued 72 notices of noncompliance, helping mitigate consumer fraud and ensure consumers receive genuine California produce.

ORGANIC VERIFICATION & SAMPLE TESTING

State Organic Program

Orange County conducts inspections under the State Organic Program (SOP), where our inspectors review organic certification and state registration documents, investigate organic complaints, and conduct random residue sampling of produce being advertised as organic.

Our inspection oversight gives Orange County consumers confidence that the organic agricultural products are authentic and grown according to State organic standards. We work with our SOP partners to register, inspect, and enforce regulations on our local organic operations at production, processing, and retail locations.

In 2025, 11 producers and 54 handlers, packers, and processors were registered in Orange County.

Pest Exclusion & Interceptions

Orange County inspectors partner with the California Department of Food and Agriculture (CDFA) and federal regulatory agencies to monitor potential pathways for the entry of agricultural commodities that can carry harmful pests. Inspections were conducted at major parcel carrier facilities and destination nurseries to detect and intercept injurious pests and plant diseases before they can become established and pose a threat to our urban landscapes, agricultural production sites, and natural environment.

In 2025, we inspected 13,433 shipments from high pest-risk areas, of which 412 failed to meet California's entry requirements and were issued Notices of Rejection. We intercepted 69 A-rated pests and 171 Q-rated pests, with exceptionally harmful interceptions noted below.

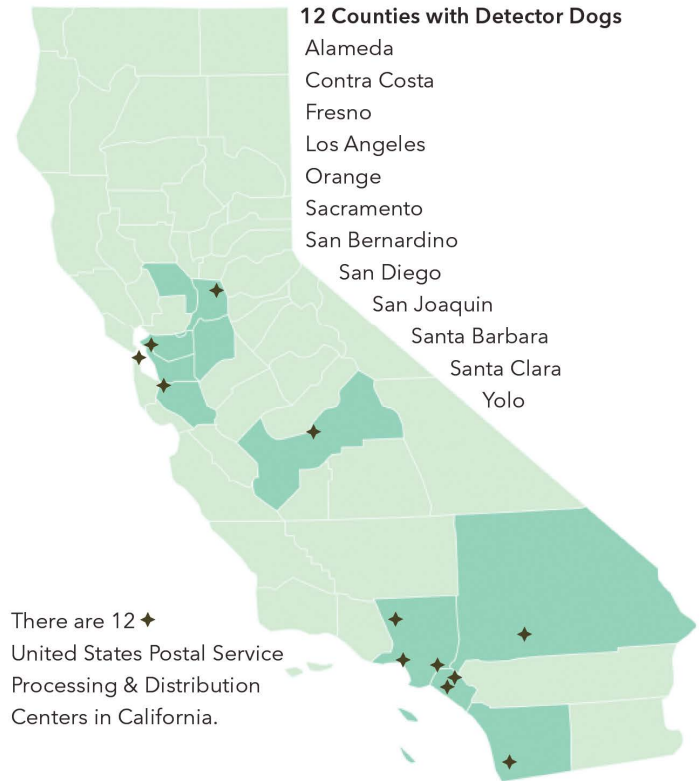

Detector Dog Teams

In 2025, Orange County expanded its Detector Dog Program with the addition of our second dog team. Handler Eugenio Vasquez and his Labrador, Georgia, joined handler Vanessa Ochoa and her detector dog, Bear. Each detection dog can inspect up to 9,000 parcels per day, vastly expanding the County's ability to intercept harmful pests before they threaten agriculture or the environment. Our dog team program is supported by federal funding, in partnership with CDFA and the California Agricultural Commissioners and Sealers Association.

Unmarked parcels are a major pathway for injurious pests to enter California, with parcels moving through the United States Postal Service facilities posing the highest risk. Since launching in June 2024, Orange County's detector dog teams have intercepted 44 harmful pests and, in 2025, issued 221 Notices of Rejection.

Huanglongbing Quarantine

In 2025, the Huanglongbing (HLB) quarantine was expanded to include all of Orange County. HLB is a bacterial disease vectored by the Asian citrus psyllid insect that kills infected citrus trees. HLB has been detected in a total of 6,735 trees at 3,933 residential properties, predominantly affecting Anaheim, Garden Grove, Westminster, Santa Ana, and Orange. The infected trees were immediately removed by CDFA staff to prevent further spread of this disease. Residents rely on these trees for fresh fruit, shade, and enjoyment, making their loss a significant impact on both households and neighborhood communities.

In 2025, Orange County inspectors surveyed 25 citrus groves and monitored harvests to ensure that regulated plant material such as stems and leaves do not leave the quarantine zone and that all bulk citrus fruit shipments were safeguarded from pest risk before leaving the quarantine zone.



Pierce's Disease Control Program

The Glassy-winged sharpshooter (GWSS) is a non-native leafhopper insect that spreads *Xylella fastidiosa*, a bacterium that causes Pierce's Disease in grapevines. This disease has no known cure and can be fatal to infected plants. The most effective way to contain its spread is by restricting the movement of GWSS on infested nursery stock. Orange County inspectors maintain GWSS monitoring traps throughout the county, perform routine host plant surveillance, and inspect regulated nursery stock prior to shipment to non-infested areas of California.

In 2025, inspectors serviced 86 monitoring traps a total of 2,214 times and certified 83 outbound shipments of GWSS host material, helping safeguard agricultural production and maintain market access for our local plant nurseries.

Fire Hazard Reduction

The Orange County Fire Hazard Reduction Weed Abatement Program, authorized under the California Health and Safety Code, helps protect public safety by reducing wildfire risks associated with overgrown weeds, dry vegetation, and other combustible materials in unincorporated areas of the county. Through routine field inspections, hazardous conditions are identified and properties with excessive vegetation, rubbish, refuse, or recurring violations are placed on the program's Fire Hazard Reduction Weed Abatement List. Property owners are issued formal abatement notices with resources on how to mitigate fire risk. When compliance is not achieved, the County performs the necessary abatement work to reduce wildfire threats and protect surrounding communities.

In 2025, the program issued 5,337 annual Fire Hazard Reduction Weed Abatement Notices to property owners throughout Orange County. County-directed abatement activities resulted in the clearing of 101 parcels, using cutting and disking methods to remove about 1,595,200 square feet, nearly 36.6 acres, of hazardous vegetation and debris to reduce fire danger and create a defensible space around structures.

PEST ALERT: *RHYNCHOPHORUS PALMARUM*

South American Palm Weevil

In August 2025, a single South American Palm Weevil (SAPW) male was detected in a trap in Irvine, marking the first documented instance of this pest in Orange County. Since then, multiple individuals have been detected in the southern half of Orange County. This large weevil is a serious pest of palms in its native range of South America. SAPW has killed over 20,000 Canary Island date palms, its preferred host, in San Diego County over the past decade.

SAPW lays its eggs in the growing tissue of palm crowns, where they hatch into grubs that bore deep into the crown while they feed, damaging and killing palms in a matter of weeks. Mature weevils emerge from infested palms and can fly up to 15 miles in a day in search of a new host. Dead palms pose a safety risk due to falling debris and should be removed and chipped to prevent the spread of this pest. Report sightings of the South American palm weevil and suspect infested palms to our office immediately.

Weights & Measures

The Orange County Weights and Measures Programs are responsible for ensuring fairness and accuracy in the marketplace. Through inspections, complaint investigations, and enforcement of California's weights and measures laws, we protect Orange County's more than 3.2 million residents while promoting a level playing field for the tens of thousands of businesses that operate in the county.

CORE ENFORCEMENT PROGRAMS

DEVICE ENFORCEMENT

Inspectors test a wide range of commercial measuring devices, from supermarket and pharmacy scales to taxi and ambulance odometers, electricity for electric vehicles, hydrogen, and compressed natural gas purchased at commercial fueling facilities. In 2025, the program registered 215,647 commercial devices at 4,183 businesses and tested 42,352 devices throughout Orange County.

QUANTITY CONTROL (PACKAGE INSPECTION)

Inspectors verify that packaged products contain the quantity stated on the label and comply with California's labeling requirements. These inspections help ensure consumers receive the amount of product they pay for while maintaining fair competition among businesses. In 2025, inspectors tested 5,007 packaged products at 196 retail locations.

FUELS, LUBRICANTS, AND AUTOMOTIVE PRODUCTS

Inspectors collect and test samples of gasoline, diesel fuel, hydrogen, motor oil, and other automotive products to ensure they meet California and federal standards for quality, labeling, and performance. These inspections protect consumers, promote engine performance, and support cleaner air. In 2025, inspectors investigated 68 public complaints and completed fuel quality inspections at 378 fueling stations.

WEIGHMASTER ENFORCEMENT

Inspectors examine licensed weighmaster operations, audit official weight certificates, and verify compliance with California's weighmaster and junk dealer/recycler laws. Accurate weight certificates are essential to ensuring fairness in commercial transactions involving commodities sold by weight. In 2025, inspectors conducted inspections at 42 weighmaster locations.

PRICE VERIFICATION

Routine inspections verify that the price charged at checkout matches the lowest advertised, posted, or displayed price. These inspections help protect consumers from overcharges while promoting pricing accuracy across the retail marketplace. In 2025, inspectors conducted price verification inspections at 1,111 retail locations throughout Orange County. Overcharges were identified on 463 (41.6%) of transactions.

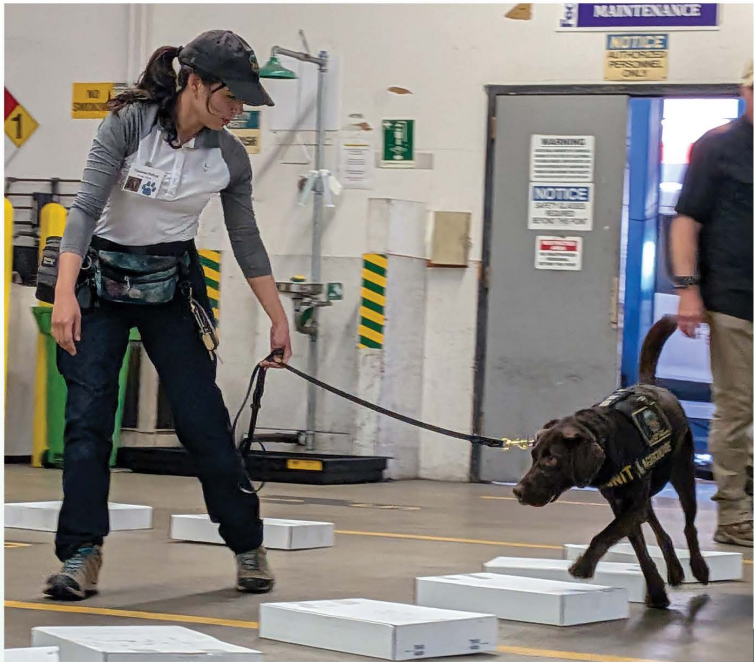
