SUBJECT: Appeal of the Planning Commission's Approval of Planning Application PA23-0119 for Use Permit.

PROPOSAL: An appeal of the Planning Commission's Approval of a Use Permit to establish residential development standards for Saddleback Meadows development through a Planned Development combining district for the approved 181-unit development.

LOCATION: Eastern side of El Toro Road, approximately one-half mile south of the intersection of Santiago Canyon Road (El Toro Road) and Live Oak Canyon Road, in Unincorporated Orange County within the Third Supervisorial District.
