RECEIVED AND FILED; DIRECTED HEALTH CARE AGENCY TO IDENTIFY HOMELESS INDIVIDUALS IN SHELTERS WHO ARE ELDERLY, AS DEFINED BY GOVERNOR NEWSOM, AND/OR WHO HAVE A CHRONIC PHYSICAL HEALTH ISSUE AND FIND ALTERNATIVE PLACEMENTS FOR THOSE INDIVIDUALS; DIRECTED OUTREACH TEAMS TO ENGAGE HOMELESS INDIVIDUALS LIVING ON THE STREET AND EDUCATE THEM ON COVID-19, PROVIDE SANITATION KITS AS AVAILABLE, AND LINK INDIVIDUALS TO SERVICES; DIRECTED CEO TO EXPLORE OPTIONS ON PROVIDING ALTERNATIVE FOOD SERVICES TO HOMELESS COUNTYWIDE; AND DIRECTED HEALTH CARE AGENCY TO ESTABLISH NEW PROTOCOLS FOR THE SHELTERS INCLUDING DISINFECTING FREQUENTLY TOUCHED OBJECTS, PROVIDING MASKS TO CLIENTS WHO ARE COUGHING, INSTALLING HAND SANITIZER AND HAND-WASHING STATIONS TO ENSURE GOOD HYGIENE, POSTING EDUCATIONAL SIGNAGE IN MULTIPLE LANGUAGES AND ENSURE SHOWER SERVICES REMAIN AVAILABLE WITH SOCIAL DISTANCING PROTOCOLS IN PLACE.
